The Cochrane Farmers' Market and the Alberta Farmers' Market Association are providing you the right to sell at the Cochrane Ranche Historical Site under permit. You do not require a separate permit from the Town of Cochrane. Please note that full-time vendors will be given priority in space assignments and the Cochrane Farmers' Market reserves the right to assign spaces and select vendors that meet the market criteria.

As a vendor:

- I understand that I am responsible for my own display materials (chair, tables, awning, etc.) Cochrane Farmers' Market cannot supply running water or electrical hook-ups.
- I understand that in respect for the customers and fellow vendors, I will be there on the dates indicated, will have my stall set-up by 9:00 a.m. and will not dismantle or vacate my space until 1:00 p.m.
- I will leave the space provided to me free of garbage. I will not use the public garbage receptacles at the Cochrane Ranches to dispose of any commercial waste.
- I understand that if I sell food products, it is my responsibility to contact the Public Health Inspector prior to coming to the market to ensure compliance with the Inspector's standards, applicable regulations and safe food practices. Cochrane Farmers Market does not refund vendor fees if the Health Inspector does not allow you to sell a product.
- In order to comply with the Personal Information Protection Act, I give consent to the Cochrane Farmers' Market to disclose my Name, Company Name and/or telephone number to those persons inquiring about my product(s).
